SUBJECT: Minimum Disaster Unemployment Assistance (DUA) Weekly Benefit Amount: October 1- December 31, 2010

1. Purpose. To transmit the subject computation for State Workforce Agency usage in computing minimum weekly DUA amounts for all major disasters declared during the first quarter of Fiscal Year (FY) 2011.
2. Average Weekly Benefit Amount (AWBA) Utilization. As required by 20 CFR 625.6, the attached listing sets forth the 50 percent of AWBA computation applicable for major disasters declared during the first quarter of FY 2011 from October 1 through December 31, 2010.
